## **Areas Accessible for Proposed Contracted Janitorial Cleaning**

Weekly Cleaning Schedule (Sunday through Saturday)

**SCOPE OF WORK:** Vacuum carpet and rugs; Dust ledges and window seals; cleans interior and exterior glass doors and windows; Dust/wet mop floors; remove all hard/stuck on matter on floors; Dust all furniture, flagpoles, cubicle tops, countertops; Clean and shine escalators (Up and Down); Mop Service Elevator.

#### **RESTROOMS:**

Floors – Sweep and mop; wet scrub public restroom weekly; empty trash/replace liners; empty, disinfect sanitary receptacles and replace liners; clean all mirrors/shelves and chrome; clean and wipe all wash basins; clean commodes (interior and exterior); clean and disinfect urinals and fixtures; polish and clean all stainless steel; clean and polish pipes under basin.

FLOOR CARE SERVICES: Wet-scrubbing weekly of all public restrooms floors. Stripping/Waxing/Buffing/Wet Scrubbing services are to be performed twice per contract period (i.e. at the initial start of the contract and six (6) months after the initial cleaning.

## Miscellaneous/Special Notations:

- Sweep/mop all public elevators daily; clean and shine interiors of all public elevators
- Mop Service Elevator at the end of nightly shift
- Transport all trash from facility to compactor; compact trash and return tilt turns to Lower Level bin area and cover with lids. Trash cannot be left unattended in the service elevator.
- Facility's grounds/entrances (sweep entryway; change liners in trash receptacles); pick up all cigarette butts and other debris.
- Clean all glass entrance doors (Poplar Avenue and Washington Street entrances)
- Sweep Grounds/Sally Port Area clear ground of all debris; change liners in trash receptacles
- Lower Level wooden doors (near ATM) must remain locked at all times after locked by Homeland Security Staff at close of business
- Set up WET FLOOR signs as needed for spills and inclement weather
- Contracted services do not include the cleaning of carpet/carpeted areas with the exception of vacuuming carpet/carpeted areas.
