TO ALL PLAN HOLDERS:

RE: Addendum No. 2 to Sealed Bid No. I-000296  
Congestion Management Program – Signal System Set #6

Please make the attached documents part of your proposal:

**Question 1:** Is it possible to separate out the concrete item for the pull boxes?

Answer: Yes, please see attached revised quantity sheet and bid form.

**Question 2:** Can an allowance be provided for MLGW work?

Answer: Yes, please see attached revised quantity sheet and bid form.

**Question 3:** How will the signal wire for the intersection of Elvis Presley and Whitehaven be spliced and extended to the new cabinet location?

Answer: A splice box will be attached to the pole and new signal wire will be run from that location to the new cabinet location. Items for the splice enclosure and signal wire have been included in the revised quantity sheet and bid form.

**Question 4:** Can you provide clarity as to what information the contractor is expected to provide for each piece of equipment that is to be installed on this project?

Answer: For all Ethernet enabled devices installed by the Contractor (including but not limited to Controllers, serial device servers, Ethernet switches, conflict monitors, RDS units, EdgeConnect card, Clary UPS unit, and GPS Opticom), the contractor shall provide the following information:

- MAC address
- Serial number
- Supplier name, address, contact, and phone number
- Manufacturer's warranty start date, duration, and contact phone number

The information shall be tabulated by device type and intersection location. The information shall be tabulated in Microsoft Excel file format and submitted electronically to the CEI, City of Memphis Signal Shop, and the local municipality.

**Question 5:** Can an allowance be provided for the equipment that will be specified by the City of Germantown IT staff?

Answer: Yes, please see attached revised quantity sheet and bid form.

**Question 6:** There is a question whether the existing conduit is in the location as shown on Drawing CL-04 Sheet 11. How do we plan on addressing the cost if additional items are needed?

Answer: Drawing CL-04 Sheet 11 was drawn using as-built plans from a previous project. The contractor should bid the project as shown on the plans. If it is determined during the construction phase that additional work or items are needed, it will be handled under a change order.

**Additional Revisions:**

Shelby County Special Provision K Central Hardware, Software, and Communications Equipment has been revised to clarify the contractor's responsibility with configuring and testing the TACTICS software in each TMC and the integration of each intersection into the TACTICS database. A copy of the special provision with track changes has been included in the addendum so that the revisions can be easily identified.
